Since 2007, he has also been Chairman of the Board of Directors of the publicly listed subgroup Sartorius Stedim Biotech S.A.

After earning a university degree in mechanical engineering in Hannover, Joachim Kreuzburg first worked at the Lower Saxony Institute for Solar Energy Research in Hameln and at the Faculty of Economics at the University of Hannover, where he received his doctorate in 1999.

In his subsequent career at Sartorius, he held various leadership positions in Finance and Controlling before being appointed to the Executive Board of Sartorius AG in 2002.

In addition to his activities at Sartorius, Joachim Kreuzburg is, inter alia, a member of the Supervisory Board of Carl Zeiss AG, Non-Executive Director of the Administrative Board of Ottobock Management SE, Member of the Senate of acatech – National Academy of Science and Engineering, Member of the Executive Board of Stifterverband für die Deutsche Wissenschaft, and Member of the Foundation Council of the University of Göttingen.
